- 1. Site applications must see be in the hands of the Secretary no later than 5pm Friday 28th July 2023. No refunds will be issued if cancelled 1 week prior to Show date.
- 2. NOTE: Additional Trade Site passes MUST be purchased with the site application otherwise additional passes will need to be purchased through Eventbrite prior to show or at the gate on show day.
- 3. In the interest of public safety, exhibitors must be on site and set up for business by 8:30am and are not to vacate sites before 5pm on show day. If you are not on site by 8:30am, entry will be refused at the gate (NO EXCEPTIONS).
- 4. The Trade site coordinator reserves the right to place trade site holders where they deem appropriate. Where possible they will accommodate special requests but are under no obligation to do so.
- 5. Any member of the committee shall have the power to enter upon the area on which the show is being conducted at any time and remove any articles, signs, pictures, or printed matter which in their opinion may be a cause of offence to the public or the officials of the committee or which the committee deems inappropriate.
- 6. All electrical equipment and extension cords must have a current electrical safety inspection tag. The committee reserves the right to disconnect any exhibitors' power for non-compliance and the exhibitor shall not be entitled to any refund.
- 7. Exhibitors are responsible for the condition of the area allotted to them for the duration of the Show and upon the completion of the Show, exhibitors shall clean such area to the satisfaction of the committee. Noncompliance will incur a fee of \$50 and/or refusal of future site applications.
- 8. NWAS Show Society Inc and the committee DO NOT provide security and shall not be held liable for loss or damage to the exhibitor's property whilst on the show grounds.
